# **Surgery Center Statement of Patient Rights**

# As a patient of Founders Surgery Center you have the right to:

- Privacy and security of self and belongings during the delivery of patient care services.
- Become informed of your rights as a patient in advance of, or when discontinuing, the provision of care. You may
  appoint a representative to receive this information should you so desire.
- Exercise these rights without regard to sex or cultural, economic, educational or religious background or the source
  of payment for care for any other act of discrimination and without any reprisal.
- Considerate and respectful care, provided in a safe environment, free from all forms of abuse, neglect, harassment and/or exploitation.
- Have your cultural, psychosocial, spiritual and personal values, beliefs and preferences respected. To assure these
  preferences are identified and communicated to staff, a discussion of these issues will be included during the initial
  nursing pre-op interview.
- · Access protective and advocacy services or have these services accessed on your behalf.
- · Appropriate assessment and management of pain.
- Remain free from seclusion or restraints of any form that are not medically necessary or are used as a means of coercion, discipline, convenience or retaliation by staff.
- Knowledge of the name of the physician who has primary responsibility for coordinating your care and the names and professional relationships of other physicians and healthcare providers who will see you. You have the right to change physicians if other qualified physicians are available.
- Receive information from your physician about your illness, course of treatment, outcomes of care (including
  unanticipated outcomes) and your prospects for recovery in terms that you can understand in a manner that
  facilitates understanding. As appropriate, communications specific to the vision, speech, hearing cognitive and
  language-impaired patient will be appropriate for the impairment.
- Receive as much information about any proposed treatment or procedure as you may need in order to give informed consent or to refuse the course of treatment.
- Actively participate in decisions regarding your medical care. To the extent permitted by law, this includes the right to request and/or refuse treatment.
- Be informed of the Founders Surgery Center policy and state regulations regarding Advance Directives.
- Full consideration of privacy concerning your medical care program. Case discussion, consultation, examination and treatment are confidential and should be conducted discreetly. You have the right to be advised as to the reason for the presence of any individual involved in your care.
- Confidential treatment of all communications and records pertaining to your care and your stay in the surgery center.

  Your written permission will be obtained before your medical records will be made available to anyone not directly
- Your written permission will be obtained before your medical records will be made available to anyone not directly concerned with your care.
- Receive information in a manner that you understand. Communications with you will be effective and provided in a
  manner that facilitates your understanding. Written information provided will be appropriate to the age, understanding
  and, as appropriate, the language of the patient.
- Access information contained in your medical record within a reasonable time frame.
- Be advised of the Founders Surgery Center grievance process, should you wish to communicate a concern regarding
  the quality of the care you receive. Notification of the grievance process includes: who to contact to file a grievance
  and that you will be provided with a written notice of the grievance determination that contains the name of the
  Founders Surgery Center contact person, the steps taken on your behalf to investigate the grievance, the results of
  the grievance and the grievance completion date.

- Be advised if your Ascension Medical Group physician proposes to engage in or perform human experimentation
  affecting your care or treatment. You have the right to refuse to participate in such research projects. Refusal to
  participate or discontinuation of participation will not compromise your right to access care, treatment or services.
- Full support and respect of all patient rights should you choose to participate in research, investigation and/or clinical trials. This includes your right to a full informed consent process as it relates to the research, investigation and/or clinical trial. All information provided to subjects will be contained in the medical record or research file, along with the consent form(s).
- Be informed by your physician or a delegate of your physician of the continuing healthcare requirements following your discharge.
- Examine and receive an explanation of your bill regardless of source of payment.
- Know which Founders Surgery Center rules and policies apply to your conduct while you are a patient.
- Have all your rights apply to the person who may have legal responsibility to make decisions regarding medical care
  on your behalf.
- · Reasonable continuity of care.

Ascension Medical Group personnel, medical staff members and contracted agency personnel performing patient care activities shall observe these patient rights.

# Patient Responsibilities

The care a patient receives depends partially on the patient. Therefore, in addition to these rights, a patient has certain responsibilities as well. These responsibilities should be presented to the patient in the spirit of mutual trust and respect.

- You have the responsibility to provide accurate and complete information concerning your present complaints, past illnesses, hospitalizations, medications and other matters relating to your health.
- You are responsible for reporting perceived risks in your care and unexpected changes in your condition to the responsible practitioner.
- You and your family are responsible for asking questions about your condition, treatments, procedures, clinical laboratory and other diagnostic test results.
- You and your family are responsible for asking questions when you do not understand what you have been told
  about your care or what you are expected to do.
- You and your family are responsible for immediately reporting any concerns or errors you may observe.
- You are responsible for following the treatment plan established by your physician, including the instructions of nurses and other health professionals as they carry out the physician's orders.
- You are responsible for keeping appointments and for notifying the surgery center or physician when you are unable
  to do so.
- You are responsible for your actions should you refuse treatment or not follow your physician's orders.
- You are responsible for assuring that the financial obligations of your medical care are fulfilled as promptly as
  possible.
- You are responsible for being considerate of the rights of other patients and surgery center personnel.
- You are responsible for being respectful of your personal property and that of other people in the surgery center.
- You are required to have a responsible adult (18 years of age or older) drive you home and stay with you for the
  period of time directed by your physician. You may not take a cab <u>unless</u> you have a responsible adult accompany
  you.

# **Founders Surgery Center Advance Directive**

It is responsibility of Founders Surgery Center to verify if a patient has an Advance Directive, or, upon request, provide information concerning Advance Directives. The term "Advance Directive" includes a Durable Power of Attorney for Healthcare Decisions, a Declaration under the Kansas Natural Death Act (also known as a "living will") and a DNR Directive.

A Surgery Center nurse will call you the day before surgery, and you will be asked if you have an Advanced Directive. If you reply is "yes", the Advanced Directive process will be as follows:

- All patients have the right to participate in their own health care decisions and to make an Advance Directive
  which authorizes others to make such decisions when the patient is unable to make or communicate them.
- You will be asked to bring a copy of the Advance Directive the day of your surgery. This will become part of your medical record.
- Before the scheduled procedure, your physician will discuss the specifics of your procedure and answer questions pertaining to risks, expected recovery and care after your surgery.
- You understand and agree that in the event of an unexpected or adverse incident during your procedure medical
  and nursing staff will attempt to resuscitate you and that you could be transferred to an acute care hospital for
  further evaluation.
- At an acute care hospital, further medical treatment or withdrawal or withholding of life sustaining medical treatment will be considered in accordance with the patient's wishes as expressed verbally or in an Advance Directive.
- A patient's agreement with this policy does not revoke or invalidate any current health care Advance Directive.

# Pediatric Rights and Responsibilities of Parents and Guardians

In addition to the rights and responsibilities of adult patients, the needs of children and adolescents, along with their parents and guardians, shall have the following rights and respect for:

- Each child and adolescent as a unique individual.
- The care-taking role and individual response of the parent
- Provision for normal physical and physiological needs of a growing child to include nutrition, rest, sleep, warmth, activity and freedom to move and explore.
- Consistent, supportive and nurturing care which:
  - Meets the emotional and psychosocial needs of the child.
  - Fosters open communication.
- Provision for self-esteem needs which will be met by attempts to give the child:
  - O The reassuring presence of a caring person, especially a parent.
  - Freedom to express feelings or fears with appropriate reactions.
  - O As much control as possible over both self and situation.
  - Opportunities to work through experiences before and after they occur, verbally, in play or in other appropriate ways.
  - Recognition and reward for coping well during difficult situations.
- Provision for varied and normal stimuli of life which contributes to cognitive, social emotional and physical developmental needs:
  - Play educational and social activities essential to all children and adolescents.
  - Information about what to expect prior to, during and following procedure or experience and support in coping with it.
- Participation of children and families in decisions affecting their own medical treatment.

FAMILY RESPONSIBILITY: the family consist of those individuals responsible for physical and emotional care of the child on a continuous basis, regardless of whether they are related.

## Parents and family shall have the responsibility for:

- Continuing their parenting role to the extent of their ability.
- Being available to participate in decision-making and providing staff with knowledge of parents and family whereabouts.

# Decreasing your risk of infection

Infection is one risk of having surgery. We take steps to decrease hospital-acquired infections as part of our effort to promote high-quality care.

The sicker you are before surgery, the higher your risk of infection.

Here are easy ways you and your family can help:

#### Wash your hands

Hand washing is the most important way to decrease the spread of infection. Start by requesting everyone who touches you to wash their hands.

## How to wash your hands

- Use soap and warm water, or, if your hands do not appear dirty, an alcohol-based hand sanitizer.
- Rub your palms, fingernails, between your fingers and the backs of your hands for at least 15 seconds the time it takes to sing "Happy Birthday" twice.

## When to wash your hands

- · Before touching or eating food
- · After using the bathroom
- · After touching surfaces in a hospital room
- · After coughing or sneezing
- · After changing a diaper
- · After touching the dressing on a wound
- · Before entering and after leaving a hospital room.

#### Cover your mouth and nose

Keep tissues handy when you sneeze or cough. Germs can travel more than three feet. If you don't have a tissue, cover your mouth and nose with the bend of your elbow or hands. Remember to wash your hands after coughing, sneezing or touching a tissue.

#### If you are sick, avoid contact with others

Don't shake hands or touch others. If you are in isolation for a contagious illness, such as flu, encourage visitors to limit their hospital visits.

#### Make sure your vaccinations are current

#### The chance of a surgical site infection is greater if:

- You have a weak immune system
- Your surgery lasts longer than three hours
- · Your surgery is done in an emergency due to trauma
- · You are already fighting an infection
- You have diabetes, cancer or kidney disease

### To lower your risk of infection:

- If you are diabetic, talk to your doctor about how to improve the control of your blood sugar. High blood sugars increase the risk of infection.
- Stop smoking, preferably at least one month before scheduled surgery. Smoking decreases blood flow and oxygen to the wound, which slows healing.
- Eat healthy foods such as fruits, vegetables, breads, dairy products, meat and fish; take vitamins and minerals if you are not getting enough nutrients in your food. Lose weight if you are over the recommended weight for your height.
- Follow instructions for caring for your wound at home. Always keep it clean and dry.
- Watch your wound for signs of infection and report them to your health care provider.
- Before you leave the hospital, make certain you know who to call if you develop a sign of infection, such as:
- Pain or hot, hard or red areas around the wound
- Fever
- · Increased wound drainage that is thick, bloody or smells bad
- Failure to heal over time

#### **Central line infections**

Patients who need frequent intravenous medications, blood, fluid replacement or nutrition may require the placement of a special tube or catheter called a central venous line or central line.

Because the line can stay in place up to several weeks, germs can grow in the line and spread to the blood. A catheter-related bloodstream infection is very serious.

### To protect against a central line infection, your health care provider will:

- Wash his or her hands with soap and water or an alcohol-based hand sanitizer.
- Dress in a sterile gown and gloves, wear a mask and cover his/her hair, then cover you, except for a small hole where the line is inserted.
- Clean your skin with a special antiseptic (iodine or chlorhexidine) before the line is inserted.
- Select the best vein for this type of line, most often in the upper chest for adults.
- Check the line every day to watch for signs of infection. The line will be taken out as soon as it is no longer needed, not on a set schedule.

### Decreasing infections from multidrug-resistant organisms

Over time, germs can change and develop resistance to antibiotics. To help prevent the increase of multidrug-resistant organisms:

- Many infections are caused by viruses and do not respond to antibiotics.
- Don't insist on an antibiotic you may not need.
- Take antibiotics exactly as directed.
- Take all the pills, even if you feel better before they are gone.
- Do not save antibiotics for a later time or share them with others.
- If you are admitted to the hospital with an infection from a multidrug-resistant organism or develop one during your hospital stay, you will receive specific information about that organism and the necessary contact precautions to prevent its spread.
- There may be signs on your door informing visitors of special precautions when entering and leaving your room.

# **General Post-Op Instructions**

#### DIET

If you are not given specific instructions by your surgeon, then following surgery it would be best to begin with liquids and light foods then progress to a regular diet. Fast food as well as greasy food should not be consumed until the day after surgery to help prevent nausea. It is a good idea to drink plenty of fluids for the first few days following surgery. You should always take your pain medication after eating something, even if it is a cracker or piece of bread / toast.

#### **ACTIVITY**

After surgery there is a fine line between going home to take it easy versus being up and about. While it is important to rest following surgery, you should get up several times during the day to go to the bathroom and to the table for meals. This activity will help to prevent blood clots in your legs and will help your bowels and bladder to function better. Please be aware that anesthesia the day of surgery as well as pain medication may affect your balance and caution should be used when walking. You should not participate in any exercise without authorization from your surgeon.

## **SEQUENTIAL COMPRESSION DEVICES (SCDs)**

In the event you have qualified for SCD sleeves, these should be used for 7 days while you are sitting or lying down to help prevent blood clots in your legs. Please remove them before you walk anywhere. It will be your responsibility to return the machine to the company. Instructions will be given to you either by the nurse or the company. Fed Ex will pick up the device and return it to the company.

#### **BLADDER**

In order for you to be able to urinate adequately, plenty of fluids should be consumed. If you are unable to urinate, please contact your surgeon or go to an emergency room.

#### **BOWELS**

Narcotic pain medication can cause constipation. Drinking plenty of fluids and getting up and walking around will help alleviate some constipation. If needed, an over-the-counter stool softener can help while on narcotic pain medication. It should be started soon after starting narcotics to have the best results. If you have no bowel movement within 3 days you may progress to a laxative. If you still have no bowel movement, contact your surgeon.

## POST-OP NAUSEA AND VOMITING

Every attempt has been made to prevent post-op nausea and vomiting. However, you may continue to experience nausea to some degree when you get home. You can minimize the chances of nausea by always taking your pain medication after eating some solid food. If you still have problems, you can treat the nausea with an over-the-counter medication. An effective over-the-counter medication is called Emetrol. If you continue to be nauseated, contact your surgeon.

### HAND WASHING

At all times either yourself or your caregiver should wash hands with soap and water prior to changing or removing your dressing. This includes band-aids as well as steri-strips.

## **INFECTION**

Any surgical procedure has the potential for infection to occur in the post-op-period. Your temperature should be taken every four hours during the day only. Should you develop a fever of 101 degrees of higher, please contact your surgeon. If you notice any drainage, sudden onset of severe pain, redness or unusual swelling, please notify your surgeon.

#### **WOUND CARE**

Specific instructions have been given to you regarding care of your surgical site. Please remember to wash your hands or have your caregiver wash their hands thoroughly with soap and water prior to touching your dressings or surgical site.
